2024 – 2025 EQUESTRIAN RULES

PLEASE READ

- ⊗ All riders are required have a permit to ride on Moreau Lake State Park lands.
- ⊗ Stay on the marked trails.
- ⊗ Horses are only allowed in designated areas of the lakes.
- ⊗ Horses are not permitted in the Nature Center, on the beach, or in the Picnic Area.
- ⊗ Ride at a walk, trot, or canter – Galloping is prohibited.
- ⊗ Horses must be properly saddled and bridled.
- ⊗ **Equestrians must clean up after their horses including out on the trails and in the parking lots.**
- ⊗ EACH horse must have a rider who is in control of only one horse at a time – No Ponying.
- ⊗ Riding double or bareback is prohibited.
- ⊗ Meet and pass other horses, walkers, and vehicles at a walk and in single file.
- ⊗ Riders aged 18 years and younger are required by law to wear an ASTM (American Society for Testing and Materials) certified riding helmet.
- ⊗ **If you choose to bring a dog with you, it must be on a leash. It is New York State Law.**

PLEASE BE SURE TO HAVE YOUR PERMIT ON YOU AT ALL TIMES
WHILE RIDING IN THE PARK.

PERMITS ARE ISSUED TO THE RIDER OR DRIVER (NOT THE HORSE).
THIS PERSON'S INITIALS APPEARS ON THE PERMIT TAG.
PERMITS ARE NOT TRANSFERRABLE.

VIOLATION OF THE RULES WILL RESULT IN PERMIT REVOCATION.
